CONDITIONS OF THE PERMIT

- 1) THE PERMIT SHALL BE GOOD FOR THE WORK DESCRIBED AND DATES SHOWN ON THIS PERMIT. THE PERMIT SHALL NOT BE EFFECTIVE UNTIL SIGNED AND DATED BY FIRESTONE.
- 2) PRIOR TO COMMENCING THE WORK THE CONTRACTOR SHALL CALL FOR UTILITY LOCATES.
- 3) THE CONTRACTOR ASSUMES ALL LIABILITY FOR THE PERFORMANCE OF THE WORK AND SHALL HOLD HARMLESS AND INDEMNIFY THE TOWN OF FIRESTONE, ITS OFFICERS, EMPLOYEES, AGENTS, AND CONTRACTORS.
- 4) THE CONTRACTOR SHALL BE LICENSED TO WORK WITHIN FIRESTONE.
- 5) THE WORK SHALL CONFORM TO ALL APPLICABLE REQUIREMENTS OF FIRESTONE, WELD COUNTY, AND THE STATE OF COLORADO AND SHALL BE WARRANTED FOR A PERIOD OF ONE YEAR.
- 6) HOURS OF OPERATION SHALL BE 7:00 A.M. TO 7:00 P.M. (OR DUSK, WHICHEVER IS EARLIEST) MONDAY THROUGH FRIDAY (EXCEPT ALL LEGAL HOLIDAYS OBSERVED BY FIRESTONE) AFTER HOURS WORK AND WEEKEND WORK IS EXPRESSLY PROHIBITED UNLESS PRIOR WRITTEN APPROVAL IS GRANTED BY FIRESTONE.
- 7) CONSTRUCTION TRAFFIC CONTROL DEVICES SHALL BE PLACED AND UTILIZED PER THE MANUAL ON UNIFORM TRAFFIC CONTROL DEVICES (CURRENT VERSION).
- 8) OPEN CUTS:
 - a) NO MORE THAN 100 LF OF TRENCH SHALL BE OPENED DURING THE DAY.
 - b) THERE SHALL BE NO OPEN TRENCHES LEFT AT THE END OF THE WORK DAY.
- 9) RESURFACING:
 - a) ASPHALT SHALL BE SAW CUT AT LEAST ONE FOOT BEYOND THE LIMITS OF THE TRENCH FOR PATCHING CURB, GUTTER, AND SIDEWALK SHALL BE SAW CUT AT EXISTING JOINTS ON EITHER SIDE OF THE TRENCH.
 - b) HOT BITUMINOUS ASPHALT PATCHES SHALL BE SIX INCHES THICK OR SHALL MATCH EXISTING PAVEMENT THICKNESS (WHICHEVER IS GREATER), SHALL BE PLACED IN LIFTS NOT TO EXCEED THREE INCHES AND SHALL BE PROPERLY COMPACTED.
 - c) PATCHES ON GRAVEL ROADS SHALL BE CLASS 6 BASE COURSE, SIX INCHES THICK.
- 10) THE WORK SHALL NOT BE MODIFIED FROM THE APPROVED PLANS WITHOUT PRIOR WRITTEN APPROVAL BY FIRESTONE. SUBSTANTIAL MODIFICATIONS MAY REQUIRE ISSUANCE OF A NEW PERMIT.
- 11) STREET CLOSURES ARE NOT PERMITTED UNLESS EXPRESSLY PROVIDED IN THIS PERMIT.
