- Help complete much-needed home repair, painting, or yard work for a resident in need

Day of Service projects are active work sites and we require direct parental/guardian supervision for volunteers younger than the age of 14.

What we do:

- Ensure the homeowner meets qualification guidelines
- Assess the property and project ahead of time
- Supply the tools and materials
- Assign a project to each volunteer group
- Supervise the work and inspect completed projects
- Provide lunch, water, and t-shirts!
